

ORDINANCE NO. 11

Compensation of President, Trustees, Clerk and Treasurer.

THE VILLAGE OF NEWBERRY ORDAINS:

The compensation of the elected officials of the Village of Newberry shall be as follows:

Section 11:1 President:

President of the Village Council (Mayor) shall receive the sum of \$150.00 each month.

Section 11:2 Trustees :

a) The Trustees of the Village Council shall receive the sum of \$50.00 each month.

b) The Trustees shall receive \$25.00 for attending any regular or special meeting of the Village Council.

Section 11:3 Clerk:

The Clerk of the Village Council shall receive the sum of \$58.33 each regular meeting together with such further compensation as may be voted upon by a majority of the Council.

Section 11:4 Treasurer:

The Treasurer of the Village Council shall receive such sums as set forth in Michigan Statute provided, however, the Treasurer may receive such alternative compensation as may be agreed upon by the Treasurer and a majority vote of the Council.

Section 11:5 General Fund:

All sums payable as compensation or for benefits in addition to compensation shall be paid from the general fund from the Village of Newberry.

Section 11:6 Repealed:


All inconsistent Ordinances are hereby repealed.



Section 11:1


b) *"The Village President shall receive the sum of \$75 for attending any regular or special meeting of the Village Council".*
