

THE VILLAGE OF NEWBERRY ORDAINS
AMENDMENTS TO ORDINANCE 26

Ordinance 26 is amended to modify Sections 26.1, 26.2, 26.4 and 26.5 to read as follows:

"Section 26.1 Creation:

There is hereby created a Planning Commission for the Village of Newberry. The Commission shall consist of **FIVE** members who shall **BE RESIDENTS OF THE VILLAGE OF NEWBERRY** and represent insofar as is possible, different professions, or occupations who shall be appointed by the Village Council. The term of office of each member of the Planning Commission shall be three (3) years, except that **ONE (1) MEMBER** of the first Commission to be so appointed shall serve for a term of one (1) year, **TWO (2)** for a term of two (2) years, and **TWO (2)** for a term of three (3) years. All members shall hold office until their successors are appointed **BY THE VILLAGE COUNCIL**.

Section 26.2 Powers and Duties:

The Planning Commission shall possess and exercise all the powers and duties as are granted, from time to time, to Village Planning Commissions by the statues of the State of Michigan, including, but not restricted to, those powers and duties provided for in Act 285 of the Public Acts of 1931, and such amendments and superseding Acts as may be enacted.

Section 26.4 Chairman, Meetings, Rules, Records:


The Commission shall elect its **CHAIRPERSON** from among the appointed members and create and fill such other of its offices as it may determine. The term of the **CHAIRPERSON** shall be one (1) year with eligibility for re-election **ANNUALLY**. The Commission shall hold a least one (1) regular meeting in each **CALANDER YEAR AND MONTHLY AS NEEDED AS DETERMINED BY THE CHAIRPERSON**. It shall keep records of its resolutions, transactions, findings and determinations. These records shall be public records.

Section 26.5 Publication and Effective Date:

The clerk shall cause a copy of this Ordinance to be published in the Newberry News **LOCAL NEWSPAPER** within 15 days and further shall make copies of this Ordinance available for public inspection at the Village Offices located **ACROSS FROM** the Newberry Water & Light Building at **302 EAST MCMILLAN AVENUE."**

This Ordinance shall be effective 20 days after publication.

An Ordinance to provide for a Village Planning Commission; The creation, organization, powers and duties of the Planning Commission,

THE VILLAGE OF NEWBERRY ORDAINS:

Section 26.1 Creation:

There is hereby created a Planning Commission for the Village of Newberry. The Commission shall consist of ~~nine~~ **FIVE** members who shall **BE RESIDENTS OF THE VILLAGE OF NEWBERRY AND** represent insofar as is possible, different professions, or occupations who shall be appointed by the Village Council. The term of office of each member of the Planning Commission shall be three (3) years, except that ~~three (3) members~~ **ONE (1) MEMBER** of the first Commission to be so appointed shall serve for the term of one (1) year, ~~three (3)~~ **TWO (2)** for a term of two (2) years, and ~~three (3)~~ **TWO (2)** for a term of three (3) years. All members shall hold office until their successors are appointed **BY THE VILLAGE COUNCIL.**

Section 26.2 Powers and Duties:

The Planning Commission shall possess and exercise all the powers and duties as are granted, from time to time, to ~~City and~~ Village Planning Commissions by the statues of the State of Michigan, including, but not restricted to, those power and duties provided for in Act 285 of the Public Acts of 1931, and such amendments and superseding Acts as may be enacted.

Section 26.3 Compensation:

All members of the Planning Commission shall serve as such without compensation.

Section 26.4 Chairman, Meetings, Rules, Records:

The Commission shall elect its ~~chairman~~ **CHAIRPERSON** from among the appointed members and create and fill such other of its offices as it may determine. The term of the ~~Chairman~~ **CHAIRPERSON** shall be one (1) year with eligibility for re-election **ANNUALLY.** The Commission shall hold at least one (1) regular meeting in each ~~month~~ **CALANDER YEAR AND MONTHLY AS NEEDED AS DETERMINED BY THE CHAIRPERSON.** It shall keep records of its resolutions, transactions, findings and determinations. These records shall be public records.



ORDINANCE 26

An Ordinance to provide for a Village Planning Commission;
The creation, organization, powers and duties of the Planning
Commission.

THE VILLAGE OF NEWBERRY ORDAINS:

Section 26:1 Creation:

There is hereby created a Planning Commission for the Village of Newberry. The Commission shall consist of nine members who shall represent insofar as is possible, different professions, or occupations who shall be appointed by the Village Council. The term of office of each member of the Planning Commission shall be three (3) years, except that three (3) members of the first Commission to be so appointed shall serve for the term of one (1) year, three (3) for a term of two (2) years and three (3) for a term of three (3) years. All members shall hold office until their successors are appointed.

Section 26:2 Powers and Duties:

The Planning Commission shall possess and exercise all the powers and duties as are granted, from time to time, to City and Village Planning Commissions by the statutes of the State of Michigan, including, but not restricted to, those power and duties provided for in Act 285 of the Public Acts of 1931, and such amendments and superseding Acts as may be enacted.

Section 26:3 Compensation:

All members of the Planning Commission shall serve as such without compensation.

Section 26:4 Chairman, Meetings, Rules, Records:

The Commission shall elect its chairman from among the appointed members and create and fill such other of its offices as it may determine. The term of the Chairman shall be one (1) year with eligibility for re-election. The Commission shall hold at least one (1) regular meeting in each month. It shall keep records of its resolutions, transactions, findings and determinations. These records shall be public records.

Section 26:5 Publication and Effective Date:


The clerk shall cause a copy of this Ordinance to be published in the Newberry News within 15 days and further shall make copies of this Ordinance available for public inspection at the Village Offices located in the NEWBERRY WATER & LIGHT BUILDING.

This Ordinance shall be effective twenty (20) days after adoption. (August 3, 1987).
